PROFILE OF THE DEPARTMENT:

Vision

1. To evolve as a center of excellence in areas of teaching, learning, research, extension and community service.
2. To equip the students to compete nationally and globally in areas of legal profession, justicing and to meet the challenges of the globalized world.
3. To strengthen traditions of knowledge and scholarship.

Mission

1. To acquire requisite skills and expertise by organizing Moot Courts, Seminars and Workshops on socio-legal issues.
 2. To nurture the students to become the soldiers of justice in realizing constitutionally enshrined goals of establishing a just society.
 3. To organize programs for students' progression and faculty development.
 4. To establish on and off the Campus Legal Service Clinic in civil society for redressal of unmet socio-legal needs.
- Veer Narmad South Gujarat University, Surat has introduced Five Years Integrated B. Com. LL.B. (Hons) Programme in the university campus from the academic year 2013-14.
 - The Legal Education Committee of The Bar Council of India has given approval to impart Five Years Integrated B.Com. LLB (Hons.) programme with an intake of two sections of 60 students in each section vide Letter No.:BCI/D/390/2013 (LE) dated 07-08-2013. The Government of Gujarat has also issued NOC to the university for this programme vide letter No.:DGJ/2013/1601/lch dated 13-05-2013.
 - At present, the programme is being conducted under the guidance of Prof. V.J. Somani, The Dean of Law Faculty & the Executive Committee. The university has appointed full-time faculty for each subject.
 - Since academic year 2012-13, the University has also introduced the LL.M. (Human Rights) Programme.
 - The Department has its own Library as well as link with the central Library of the University.
 - The Students will have to take part in Legal Aid Clinic / Centre and 12 weeks Internship and will have to follow prevailing syllabus suggested by Bar Council of India, University Grant Commission and University.

➤ **The Department**

Looking to the needs of specialized courses in Law, a separate Department was established in the University Campus. There are two courses run by the University at the Department namely Department of law, a 5 year integrated course & B.Com LL.B & a 2 year PG course LL.M (Human Rights) . The institute has a spacious building with all necessary infrastructures for running these courses.

➤ **B.Com LL.B. Course**

The Institute runs a five-year integrated B.Com LL.B. course in which HSC or equivalent level pass out students are admitted and rigorous training is imparted to them for 5 years continuously.

➤ **Semester System**

This course structure follows semester system and allows the students to complete their post graduation in five years (10 semesters).

➤ **Bachelor Degree and Master Degree**

After completion of B.Com. LL.B., the students may continue studies of LL.M (H.R.) or may join any other post graduate course. The degrees are awarded by Veer Narmad South Gujarat University, Surat. On attaining B.Com LL.B, student may start career as a Legal professional or may pursue higher studies.

➤ **Admissions**

The intake of students for the year of B.Com .LL.B. : 2018-2019 is 120.

Out of **120 seats**: 45% for General Category, 40% for S.C. / S.T. Category, 42% for OBC Category.

Age: Maximum 20 Years for General Category & 22 Years for S.C. / S.T. / S.E.B.C Category.

Medium of Instruction and Exam: English

➤ **Eligibility Criteria**

The candidate will be granted admission purely on the merit, based on aggregate marks obtained by the candidate in HSC / Equivalent Examination. Marks obtained in practical will be included in calculating aggregate marks.

A candidate who has passed HSC / Equivalent Examination from Any Stream.

A candidate, who has passed HSC / Equivalent Examination with more than one attempt, is also eligible to apply. However, he/she will be placed in the merit list after deducting 2% marks per additional attempt.

➤ **Quota/Reservation/Allotment:**

Quota/Reservation/Allotment, as Per guidelines prescribed by the university and state government from time to time..

➤ **Merit List**

Merit list will be based on aggregate marks obtained by the candidate in HSC examinations /Equivalent Examination. Marks obtained in practical will be included in calculating aggregate marks.

In the event of a tie, the tie will be resolved by following order:Comparing percentage of S.S.C. Examination, then Comparing Birth date.

A candidate, who has passed HSC/ Equivalent Examination with more than one attempt is also eligible to apply, however, candidate will be placed in the merit list after deducting 2% marks per additional attempt.

➤ **Course Fees**

B.Com. LL.B. Course Fees: Rs 25,000/- (Tuition Fees) per Semester
+ Rs 1,760/- (Other fees & Deposit of the University)

➤ **Instructions to the students regarding discipline/attendance/examination**
