Online applications are invited for admissions to Ph.D. on **www.vnsgu.ac.in**. The last date for submitting online application is 15/09/2021.

Detailed information including eligibility criteria is in accordance to the Ph.D. Ordinance available on university website, candidates are advised to study the ordinance. In case candidate wants to apply for more than one subject he/she shall have to submit separate application form for each subject. Processing fees for each application Rs.800/- is to be deposited by net banking, credit card/debit card or UPI only. Candidates are advised to visit university website and their dashboard regularly.

Note:

Admission to the Ph.D. shall be subject to the available vacancies at the time of admission, however if the candidate gets qualified for Ph.D. admission by passing entrance test and the vacancy is not available in that subject at the time of admission, the score of entrance test shall be valid for the forthcoming admission cycle without deducting the attempt from the total validity of entrance test.

INSTRUCTIONS

1	PROCEDURE FOR SUBMISSION OF APPLICATION AND UPLOADED DOCUMENTS :
a	Open the link Ph.D. Admission 2021
b	Submit the details regarding admission and upload the following documents with online application form :
b-a	All Semester's mark sheet of Under Graduate Courses. The applicant who has obtained Post Graduate degree in CBCS mode (Grading System), shall have to submit percentage conversion table/formula issued by the concern university. (if conversion formula is printed on mark sheet there is no need to submit any other document pertaining to conversion of CGPA) (single pdf, maximum 5 mb)
b-b	For JRF, M.Phil., NET, SLET, GATE : Mark sheet of qualifying exam,
b-c	Cast certificate & other certificates like E.W.S., Non creamy layer certificate etc. (if applicable)
d	After submission an application fee shall have to be paid online by Debit - Credit Card / NET Banking, UPI only
e	After the submission of fees, hard copy of application form will be generated online.
f	Online documents Verification will be done by university hence the applicant does not have Visit University personally for documents verification.
2	Those who have Post Graduate Degree / M. Phil Degree from Off campus Center / Study center outside their main campus or through distance learning mode of the university without the approval of University Grant Commission are not eligible for the Ph. D. programme.
3	Since the validity period of entrance exam is one year or at least one succeeding entrance exam, the applicants who have qualified the entrance exam held on 23-24-25/2/2021 but did not get admission have an option to get exemption from entrance examination of this admission process. Those who are willing to claim exemption from appearing in entrance examination must claim exemption in writing and shall have to submit the same along with printout of admission form.
(B) Eligibility for Ph.D. Programme :	
1	<u>OTHER THAN THE FACULTY OF MEDICINE AND HOMEOPATHY :</u> Master Degree with at least 55 % for OPEN category and at least 50 % in the case of SC / ST / SEBC / PH category candidate) from this or any other university recognized by the U.G.C. <u>Note : Chartered Accountants and Company Secretary with Graduation are eligible for admission to Ph. D. in Commerce Faculty</u>
2	<u>FACULTY OF MEDICINE : (Only Ph.D. Programme)</u> a) The student who has passed M.D./ M.S./ M.Sc. (Medical) examination from this university or from any university recognized by the M.C.I. will be eligible for admission to the Ph.D. programme. b) Also, the student having a post graduate diploma in the Faculty of Medicine and one year professional experience in concerned subject will be eligible. <i>Also it be noted that, only if the seats remain vacant after the procedure for admission under the 2(a) category stated above, the vacant seat may be allotted to the candidate eligible under 2(b) category stated above. Applicant having non medical degree is not eligible for the Ph.D. Programme.</i>
(C) Choice of admission category : Applicant shall choose admission under any one category for which he / she is eligible as mentioned below : 1. Qualified only Master Degree category (Eligible for Entrance Exam) 2. Qualified JRF/ NET /SLET/ GSLET / GATE / M.Phil. category (Exempted for Entrance Exam)	
(D) Payment of Application Fee : The non-refundable application Fees for Ph.D. programme under all categories will be <u>Rs. 800 /-</u> only. Student shall have to pay the amount by Debit Card / Credit Card / NET Banking.	
(E) Structure and Syllabus of Entrance Exam will be declared later on.	
(F) Entrance Exam related information will be declared later on.	
(G) Eligibility for Presentation of Research Proposal :	
1	<u>Online Entrance Examination Category</u> As per University norms, those who secure at least 50 % for Open category and 45 % for SC/ST / SEBC / P.H category in the Entrance Test will be qualified for Presentation of Research Proposal.
2	JRF / NET / SLET / GSLET / GATE / M.Phil. Qualified category will also be eligible for Presentation of Research Proposal.
(H) <u>Seat Reservation:</u> Seat reservation as per the norms laid down by the UGC / State Govt. / VNSGU..
